WHEREAS, the Court has considered the competing motions for Appointment of Lead Plaintiff and Approval of Lead Counsel, and the agreement of the Davis Entities and the CME Investor Group, and the position of Matthew Menges;

IT IS HEREBY ORDERED THAT:

1. Class members, Irrevocable Trust FBO Lansing Davis under agreement dated 10/1/1979 and the Davis Partnership LP (collectively the "Davis Entities"), are appointed to serve as Lead Plaintiffs in the above-captioned actions pursuant to 15 U.S.C. § 78u-4(a)(3)(B). Class members, John and Jennifer Houghton, Ethan Lamar Pierce and Susan Shaffer (collectively the "CME Investor Group") are appointed as additional interim representative plaintiffs.

2. The law firm Hagens Berman Sobol Shapiro LLP is appointed Lead Counsel for the Davis Entities in the action. The law firm Cohen Milstein Sellers & Toll PLLC is appointed interim co-counsel for the putative class in the action.

3. Lead Counsel shall have authority to speak for Plaintiffs in matters regarding pretrial and trial procedure and settlement negotiations, and shall make all work assignments in such manner as to facilitate the orderly and efficient prosecution of this litigation and to avoid duplicative or unproductive effort. Co-counsel shall have the right to receive and review all pleadings as is necessary in their duties to the class, participate in hearings and raise issues with the court in such manner as does not interfere with the orderly and efficient prosecution of this litigation and avoids duplicative or unproductive effort.

4. Lead Counsel shall be responsible for coordination of all activities and appearances on behalf of Plaintiffs and for the dissemination of notices and orders of this Court. No motion, request for discovery or other pretrial proceedings shall be initiated or filed by Plaintiffs except through Lead Counsel.


5. Lead Counsel shall also be available and responsible for communications to and from this Court. Lead Counsel shall be responsible for the creation and maintenance of a master service list of all parties and their respective counsel.

6. Defendants' counsel may rely upon all agreements made with Lead Counsel or other duly-authorized representatives of Plaintiffs, and such agreements shall be binding on Plaintiffs.
