In 2021, Harvard Law School awarded Ms. Miller the Wasserstein Fellowship, an honor that recognizes lawyers with distinguished careers in public service and a proven commitment to mentoring students. She was the 2021 recipient of *The National Law Journal’s* Visionary Award, which honors a member of the bar who has shown extraordinary creativity in bringing the legal industry together and supporting the professional development of attorneys across the country. Since 2020, Ms. Miller has co-chaired the Women’s Leadership Forum at the National Trial Lawyers Summit, which convenes emerging and established women leaders for the purpose of sharing wisdom and amplifying the influence of women in the legal profession.

Ms. Miller graduated Phi Beta Kappa and *magna cum laude* from Dartmouth College and, upon graduating from Harvard Law School, was awarded the Kaufman Public Interest Fellowship and the Heyman Government Service Fellowship. She holds certificates in Leadership Coaching and Navigating Polarities from Georgetown University.
